**NOTIFICATION**

Whereas the UGC-DEB mandate [vide their F.No.9-4/2018 (DEB-III); dated 16 August, 2018 and F.No.9-4/2018 (DEB-III dated 24 October, 2018), it has become an absolute necessity to fill-up the vacant sanctioned posts of teaching faculties on exigent basis- so that, 5 teaching faculties per some of the academic departments (e.g. Bengali, English, Economics, Social Work, LIS, etc.) can be ensured,

Whereas Director, School of Professional Studies, NSOU has given suggestion to engage a new Faculty for the Department of Library and Information Science,

Whereas the Selection Committee for recruitment of Professor, Library and Information Science has recommended the name of Dr. Arun Kumar Chakraborty, since retired (DoB - 25.12.1961) from the post of Librarian, Bose Institute, Kolkata,

Whereas the Vice-Chancellor has been empowered by the Executive Council to engage temporarily against any sanctioned posts from retired personnel having required qualification,

Whereas the Hon'ble Vice-Chancellor is the appointing authority according to Para no.25A of the West Bengal Act XII of 2011,

Whereas Dr. Arun Kumar Chakraborty, now a retired Librarian of the Bose Institute, Kolkata (Retired on 31.12.2021) has been selected for appointment to the Post of Professor, Library and Information Science on contractual basis in NSOU.

Therefore, as approved by the Hon'ble Vice Chancellor the undersigned is directed to engage Dr. Arun Kumar Chakraborty as a Professor in Library and Information Science under aegis of School of Professional Studies, NSOU on contractual basis for the period till he attains the age of 65 years (i.e. upto 31.12.2026). His remuneration will be calculated on the basis of last pay drawn less Pension before commutation plus admissible allowances (DA & HRA, etc. of Govt. of WB) as per rule.
