**Sub: Engagement of Assistant Professor of Special Education (M.Ed. Spl. Edn)**

Whereas Netaji Subhas Open University (NSOU) has been granted No Objection Certificate (NOC) by the Rehabilitation Council of India (RCI) to start M.Ed. Spl. Edn in ODL mode by the University at its own fold,

Whereas it is mandatory to show the strength of faculties to start the said programme along with B.Ed. in Special Education as per RCI guidelines,

Whereas School of Education has already developed the SLMs for M.Ed. Spl. Edn,

Whereas the SLMs have been duly approved by CIQA meeting.

Whereas the University has taken decision to submit application online before the UGC, to approved the said M.Ed. Spl. Edn programme for the session 2019-20(January session ) onward,

Whereas it is precondition to show the faculties in position as on date for said programme,

Whereas the University is yes to appoint regular faculties against the vacant posts allowed to be filled up by the State Govt.- due to non-receipt of applications or want to suitable candidate,

Whereas the Director School of Education has recommended the name of the retired faculty,

Whereas the Vice-Chancellor has been empowered by Executive Council (NC) of NSOU to engage such faculty on temporary contractual basis of urgency of the University,

Therefore, the undersigned has been directed to engage Smt. Baby Datta (Chaudhuri), Ex-Officer in Charge at NIVH-RC, Kolkata on temporary contractual full time dedicated as Assistant Professor of Special Education under School of Education, NSOU for three months (renewable subject to satisfactory performance) from the date of her joining.

The undersign is further directed to state that Smt. Datta (Chaudhuri) will be allowed Rs. 21,600/- as consolidated contractual remuneration (being the pay at the entry level for faculty) per month. However, the engagement may be terminated with one-month prior notice from both ends. Other terms and condition will be as per norms of the University.
