Dear Sir,

With reference to your application dated 12.02.2010 for the post of Assistant Professor in English at Netaji Subhas Open University and following the decision taken by the Executive Council of the University in its 65th meeting held on 14.12.2010 and 15.12.2010, the University Administration has been pleased to offer you appointment in the post of Assistant Professor in English at Netaji Subhas Open University in the pay band of Rs. 15,600-39,100 with Academic Grade Pay of Rs. 6000 plus usual allowances as per University Rules, subject to the following terms and conditions:

1. You will be on probation for a period of one year, which may be extended for another year. On satisfactory completion of the probationary period, your service under this University will be confirmed. If your work is not found to be satisfactory during the period of probation, you may be discharged by the competent authority with one month's notice.
2. Your appointment is subject to your being found physically fit. In this regard, you are required to submit a medical certificate in original issued by any registered medical practitioner working in any Government hospital certifying your physical fitness.
3. You are required to submit all certificates and marksheets in original to the undersigned for verification at the time of joining the post. You are also required to submit the release order from your present employer.
4. You shall submit the joining report to the Registrar.
5. Your date of birth shall be determined according to your date of birth as entered in your School Leaving Certificate. For verification of age, you will have to provide evidence as mentioned above at the time of joining the post.

6. You are required to submit your Last Pay Certificate from your present employer for fixation of your pay at this University.
7. You may relinquish your service under this University with one month's notice within the probationary period and with three month's notice after confirmation.
8. You will not be permitted to apply for any post elsewhere during the period of probation.
9. In the event of continued misconduct and unsatisfactory performance on your part, which is detrimental to the interest of the University, you will be liable for appropriate disciplinary action.
10. If the University suffers any financial loss due to any deliberate act of omission and/or commission on your part, you shall be liable to compensate the University for the said loss in addition to such disciplinary action as may be deemed necessary by the competent authority.
11. You will be governed by the Act, Statutes, Ordinance, Regulations and Rules of this University, as may be in force from time to time.
12. Your age of superannuation will be as per rules of the University.

You are requested to join by 01.03.2011.

You are requested to convey your written acceptance of this offer of appointment to the undersigned within 15.02.2011.
