## **NOTIFICATION**

Whereas as per the UGC-DEB mandate (vide their F.No.-9-4/2018 (DEB-III); dated 16<sup>th</sup> August, 2018), it has become an absolute necessity to fill up the vacant sanctioned posts of teaching faculties on exigent basis.

And whereas, it is not possible at this moment to engage a/an Assistant Professor/ Associate Professor/ Professor afresh against existing sanctioned posts as recruitment is under process.

And whereas, the Vice-Chancellor has been empowered by the Executive Council to engage temporarily against any sanctioned posts from retired personnel having required qualification.

And whereas, the Vice-Chancellor is the appointing authority according to Para no.25A of the West Bengal Act XII of 2011 (published on 25.01.2012),

And whereas, Smt. Debarati Banerjee, a retired Associate Professor in History from Rani Birla Girls College, retired on 30.06.2016 has applied before the Vice-Chancellor to be considered to engage as a Faculty member in History in this University,

And whereas, Director, School of Social Sciences, NSOU has recommended to engage, Smt. Debarati Banerjee as Associate Professor in History,

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Smt. Debarati Banerjee as an Associate Professor in History, under aegis of School of Social Sciences, NSOU on purely temporary contractual basis as full time dedicated faculty for 3(three)months from the date of her joining. Her remuneration will be fixed as consolidated one either to be calculated on the basis of last pay drawn less Basic Pension plus admissible allowances or Rs. 70,000/- whichever is less.


