NOTIFICATION

Whereas as per the UGC-DEB mandate [vide their F.No.-9-4/2018 (DEB-III); dated 16th August, 2018], it has become an absolute necessity to fill up the vacant sanctioned posts of teaching faculties on exigent basis.

And whereas, it is not possible at this moment to engage a/an Assistant Professor/ Associate Professor/ Professor afresh against existing sanctioned posts as recruitment is under process.

And whereas, the Vice-Chancellor has been empowered by the Executive Council to engage temporarily against any sanctioned posts from retired personnel having required qualification.

And whereas, the Vice-Chancellor is the appointing authority according to Para no.25A of the West Bengal Act XII of 2011 (published on 25.01.2012),

And whereas, Dr. Soumitra Sreeemani, a retired Associate Professor in History from P.N. Das College, West Bengal (Retired on 31.10.2015) has applied before the Vice Chancellor to be considered to engage as an Associate Professor in History,

And whereas, Director, School of Social Sciences, NSOU has recommended to engage, Dr. Soumitra Sreeemani an Associate Professor in History,

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Dr. Soumitra Sreeemani an Associate Professor in History under aegis of School of Social Sciences, NSOU on purely temporary contractual basis as full time dedicated faculty for six months from the date of his joining. His remuneration will be fixed as consolidated one to be calculated on the basis of last pay drawn less Basic Pension plus Admissible allowances on such pay. Other entitlements will be as per existing rules/norms of the University or as may be framed from time to time.
