**NOTIFICATION**

And whereas, on the basis of recommendation of a duly constituted selection committee, Prof. (Dr) CMA Ashoke Kumar Sarkar has been recommended to engage as a Professor in MBA programme on purely temporary basis,

Therefore, as approved by the Vice Chancellor, the undersigned is directed to engage Prof. (Dr) CMA Ashoke Kumar Sarkar as Professor in MBA (self-financed) programme under aegis of School of Professional Studies at NSOU (HQ) on purely temporary basis as full time dedicated Faculty for a period of 1 (one) year subject to periodic renewal by the appropriate authority with effect from the date of his joining.
