And whereas, the Vice-Chancellor is the appointing authority according to Para no.25A of the West Bengal Act XII of 2011 (published on 25.01.2012),

And whereas, Sri Ratanes Misra, a retired Associate Professor in Mathematics retired on 30.11.2016 from Santipur College, has applied before the vice Chancellor to be considered to engage as an Associate Professor in Mathematics,

And whereas, Director, School of Sciences, NSOU has recommended to engage, Sri Ratanes Misra as an Associate Professor in Mathematics,

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Sri Ratanes Misra as an Associate Professor in Mathematics under aegis of School of Sciences, NSOU on purely temporary contractual basis as full time dedicated faculty for six months from the date of his joining. His remuneration will be fixed as consolidated one to be calculated on the basis of last pay drawn less Basic Pension plus Admissible allowances on such pay. Other entitlements will be as per existing rules/norms of the University or as may be framed from time to time.
