**NOTIFICATION**

Therefore, as approved by the Vice Chancellor, the undersigned is directed to engage Dr. Basabi Chakraborty as an Assistant Professor in Public Administration under aegis of School of Social Sciences at Kalyani Regional Centre, NSOU on purely temporary contractual basis as full time dedicated Faculty for a period of 1 (one) year subject to periodic renewal by the appropriate authority with effect from the date of her joining. Her consolidated pay is fixed at Rs. 45,000/- (Forty- five thousand) per month only.
