- As per the MoU with NSOU, admission as well as examination of above said courses shall be conducted by the University in accordance with the ordinances issued by NSOU. However, the Council reserves right to monitor the standard and norms of the training courses and depute a team of experts during the period of contact classes and examinations at the University.
- The NSOU, Kolkata will be responsible for admission procedures, enrolment of the eligible candidates, commencement of academic session, period of the contact classes, schedule of examination, award of Degree etc. under intimation to the Council from time to time.
- In case of violation of the RCI norms in respect of said courses, the Council may take appropriate action and may discontinue the course at the University at any time.
- NSOU, Kolkata is advised to submit the following documents to the Council, prior to 5. commencement of the course: -
 - Copy of UGC-DEB approval to start M.Ed.Spl.Ed.-ODL (Hearing Impairment & Intellectual Disability) Course.
