Recruitment Notification (Faculties)

Netaji Subhas Open University (NSOU) having its Head Quarters at DD-26, Salt Lake City, Sector-I, Kolkata-700064 and three Regional Centres at Kalyani, Distt: Nadia; Jalpaiguri and Durgapur, Distt: Burdwan (West) invites applications for the following teaching posts from Indian nationals. Applications must reach the University within 6th March,2020 during office hours (within 5.00 PM) on all working days. Applications must be submitted in duplicate in prescribed pro-forma as given in University Website and submitted at the University Headquarters (in respective drop box) at DD – 26, 5th Floor, Salt Lake City, Sector – I, Kolkata – 700 064 or may be sent by post. The envelope containing the application must indicate the name of the post applied for including its reservation status in bold.

Payment of Application Fees:

Application fee Rs. 1,000/- (Rs.500/- for SC/ST/OBC/PH category) must be submitted through online dedicated payment gateway service. The link will be available on and from **15.02.2020 to 06.03.2020** (tentatively). To pay the requisite fee please visit www.wbnsou.ac.in and click on “PAY ONLINE” under “Recruitment” menu. After payment take print out of “Payment Confirmation Receipt” and enclosed the same with application form.

Applications without application fee and other documents as prescribed are liable to be cancelled without intimation.

I. For Minimum Eligibility Criteria, Pay Band with AGP and other details relating to the posts mentioned against Sl. Nos. A - 1 to 16, B- 1 to 13 and C-1 to 4 the attached G.O. notification vide No.516-Edn(U)/1U-91/10 dt.16.05.2017, issued by Dept. of Higher Education, Science & Technology and Biotechnology (University Branch), GoWB and Rehabilitation Council of India (RCI) Rules for Special Education should be consulted and to be followed strictly at the time of filling up the application form.

II. Qualification for posts under Special Education :

A. Minimum eligibility criteria for Assistant Professor of Special Education (mentioned against Sl. No. C- 4)

Essential:

- (i) Master's Degree in any discipline with not less than 55% of marks.
- (ii) M.Ed. Degree in specific disability area with not less than 55% marks (or an equivalent grade in a point scale wherever grading system is followed) as recognised by Rehabilitation Council of India (RCI) or an equivalent degree from a foreign university recognized by the RCI.

Desirable:

- (i) M.Phil / Ph.D in Special Education or Education with research emphasis on Special Education;
- (ii) Experience for a period of at least 2 years as teacher or researcher in the area of specific disability

B. Minimum eligibility criteria for Associate Professor (mentioned against Sl. No. B-4)

Essential:

1. Masters Degree in any discipline with not less than 50% of marks
2. M.Ed. Degree in specific disability area with not less than 55% of marks Or an equivalent grade of B+ in 10- point scale of UGC.

OR

3. An equivalent degree from a foreign university recognized by RCI.



4. Ph.D in Special Education or Education with research emphasis on Special Education.
5. Should have completed at least 8 years of teaching experience as faculty out of which minimum 5 years should be in specific disability area.
6. Should have completed at least one general orientation course and two refresher courses in education / special education of UGC.
7. Valid registration with RCI u/s 19 of RCI Act 1992 is essential

Desirable:

Minimum 3 publications pertaining to Special Education in indexed journals and research experience.

C. Minimum eligibility criteria for Professor (mentioned against Sl. No. A-4)

Essential:

1. Masters Degree in any discipline with not less than 50% of marks
2. M.Ed. Degree in specific disability area with not less than 55% of marks Or an equivalent grade of B+ in 10- point scale of UGC
OR
3. An equivalent degree from a foreign university recognized by RCI.
4. Ph.D in Special Education or Education with research emphasis on Special Education.
5. Should have completed at least 10 years of teaching experience as faculty out of which minimum 05 years should be in specific disability area.
6. Should have completed at least one general orientation course and two refresher courses in education / special education of
7. UGC .
8. Valid registration with RCI u/s 19 of RCI Act, 1992 is essential

Desirable:

Desirable: Minimum 5 publications pertaining to Special Education in indexed journals and research experience.

IMPORTANT TO NOTE : REGARDING OTHER CRITERIA [such as age, pay band with AGP etc. (for Teacher Training in Special Education (i.e Special B.Ed. & Special M.Ed.) the attached G.O. notification vide No.516-Edn(U)/1U-91/10 dt.16.05.2017, issued by Dept. of Higher Education, Science & Technology and Biotechnology (University Branch), GoWB should be followed.

GENERAL INFORMATION

1. Application forms submitted by the applicants should be properly filled in all respects by the applicants concerned and all the entries therein must be substantiated by supporting documents without which such applications would be treated as cancelled. All relevant supporting documents with self-attestation are to be attached with the application form.
2. It is to be noted that applications without application fee would be cancelled.
3. Already employed applicants should apply through proper channel.
4. The prescribed essential qualifications/experience indicated above is bare minimum and mere possession of the same will not entitle the candidates to be called for interview. It is also to be noted that NSOU reserves the right to raise the cut-off level of eligibility criteria



- than those indicated under the “Essential Qualifications” for the respective posts.
5. All the posts advertised are sanctioned by the Govt. of West Bengal and the age of superannuation for all the incumbents appointed to these posts would be 65 years or as may be notified by the Govt. of West Bengal from time to time.
 6. All the incumbents appointed to these posts are transferable from one campus/ Regional Centre etc. of NSOU to the other.
 7. The age of an applicant should be less than the maximum as indicated in the text or/ 65 years (whichever is less) on the closing date of application, i.e. 6th March,2020 wherever applicable. The age relaxation at entry point is admissible for reserved & PH category as per Govt. rule but not beyond 65 years.
 8. A relaxation of 5% in marks (wherever necessary) maybe provided for candidates (applicable for candidates domiciled in West Bengal) belonging to SC/ ST/ OBC/ Differently abled (physically as well as visually) categories.
 9. For Upper age limit/Age limits for all the above posts kindly refer to G.O. notification vide No.516- Edn(U)/1U-91/10 dt.16.05.2017, issued by Dept. of Higher Education, Science & Technology and Biotechnology (University Branch), GoWB.
 10. University Authority will not be responsible for any postal delay in case of receipt of application by the University or receipt of Interview call letter by the applicant.
 11. No TA/DA shall be paid to candidates for attending interview.
 12. Only the selected candidate(s) in respect of the aforesaid posts (if any) will be intimated accordingly.
 13. The University reserves the right not to fill up the post advertised or modify the vacancy position without assigning any reason.
 14. In case of any dispute the decision of the university will be final.
 15. Applicants for the post of Associate Professor and Professor while calculating their API are required to follow strictly the norms as laid down in G.O. notification vide No.516-Edn(U)/1U-91/10 dt.16.05.2017, issued by Dept. of Higher Education, Science & Technology and Biotechnology (University Branch), GoWB.
 16. The marks in each case mean the qualifying marks without any grace marks and/or rounding off procedure.
 17. A relaxation of 5% marks may be provided for the minimum eligibility marks of 55% at the Master level to the Ph.D. degree holders who have obtained their Master degree prior to September 19, 1991.
 18. Period of time taken by the candidates to acquire M.Phil. and/or Ph.D. degree shall not be considered as teaching/research experience to be claimed for appointment to the post of Associate Professor/Professor.
 19. A cut-off score as may be obtained from the Academic Performance Indicator (API) based Performance Appraisal System (PBAS) may be stipulated while deciding on the selection criterion by the University.

 21. For any litigation the judicature will be under the Hon’ble High Court at Kolkata.
