Qualification obtained must be from recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.	
3	No TA/DA will be paid for attending the Selection Process.	
4	In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the university reserves the right to <i>modify</i> , <i>withdraw</i> or <i>cancel</i> any communication made to the Applicants.
