AUTO UPGRADATION OF SEATS:

If vacancy occurs due to non-receipt of fees from the candidates of higher merit, candidates from next higher merit (who have paid the fees within stipulated time as mentioned above) will get a chance of auto upgradation of seats (if preference value for his/her current allotted seat at Study Centre is lower than the vacant seat at a Study Centre).

Chance of auto upgradation of seats will be given merit wise. During auto upgradation process all the options of candidate with higher merit will be considered first then the options of the next higher merit candidates will be considered.

Once the candidate is selected in one option, all the lower options will be closed, only higher options if available, remain open for future chances.

As auto upgradation may be done, the **Study Centre printed on payment confirmation** will be provisional till completion of all round of counselling/ seat allotment process. On completion of all round of counselling/ seat allotment process, final payment confirmation receipt will be available wherein the name of the Study Centre finally settled and will be printed. The candidate will have to accept that Study Centre allotted finally.

Note: Auto upgradation of seats has been done for the candidates enlisted in 1st merit list and those who has paid the requisite fees in due time are advised to logon on to PG admission site (pg.wbnsouadmissions.com) and take print out of payment confirmation receipt for future reference.

GENERAL INFORMATION:

- 1. Allotment of seats were done as per order of preference for Study Center given by the approved eligible applicants during online application submission process and on the basis of merit and availability of seats in respective Study Centres for the respective course.
- 2. Reservation of seats for SC/ST/PH/OBC-A/OBC-B were done for candidates of West Bengal only and reservation done following Govt. of WB rule.
- 3. A candidate from 1st merit list missing his/her chance for any reason will in no case be accommodated in any subsequent phase of counselling /seat allotment.
- 4. Counselling/ seat allotment will continue in phases till availability of seats for admission. The counselling/ seat allotment process of a particular category will be declared closed instantly as soon as all seats for admission in that category are filled up. No further queries in this regard will be entertained.
- 5. All the rules are subject to change by the order of the appropriate authority.
- 6. University reserves the right to cancel admission of a candidate at any time and in this regard decision of the University is final.
