
Compliance against point 17, Are the proposed programme under the ambit of any regulatory authority. If yes, approval of regulatory bodies submitted for all such programmes:

AICTE approval submitted is not for current year for MBA programme:

AICTE has issued **NOC to run MBA programme in ODL mode for Academic Year 2022-23** against vide F.No. Eastern/2022-23/1-11274172271 dated 30th May, 2022 ([Click Here](#)). Subsequently, AICTE has also issued a letter vide AICTE/AB/ODL-OL/2022-23 dated 29.6.2022 stating that the **NOC will remain valid for five years upto 2026-27** ([Click Here: page 3](#)).

Regulatory approval of RCI not submitted for M.Ed. (Special Education) programme:

Memorandum of Understanding (MoU) has been signed between Rehabilitation Council of India (RCI) and Netaji Subhas Open University (NSOU) where in RCI has made provision to approve and offer the said courses through open distance learning mode ([refer: point 1 to 18 of page 6 to 8](#)). The MoU has also been endorsed by the RCI official communication against vide file No.: 10-11/NSOU/2007/RCI dated 16.12.2022 ([Click Here](#)). University has uploaded the said MoU during filling up of application as approval of regulatory authority for proposed program MASTER OF EDUCATION - SPECIAL EDUCATION(INTELLECTUAL AND DEVELOPMENTAL DISABILITY/ HEARING IMPAIRMENT) and BACHELOR OF EDUCATION - SPECIAL EDUCATION (INTELLECTUAL AND DEVELOPMENTAL DISABILITY/ HEARING IMPAIRMENT / VISUAL IMPAIRMENT). NSOU has also forwarded the same, annexed in "PART-B: ANNEXURES" (spiral bound book) along with the certified hard copy of online application form on 6th April, 2023. However, NSOU is again uploading the MoU and official communication of RCI.
