NOTIFICATION

And whereas, on the basis of recommendation of a duly constituted selection committee, Dr. Mukti Ganguly has been recommended to engage as full time Professor in Special Education on purely temporary basis,

Therefore, as approved by the Vice Chancellor, the undersigned is directed to engage Dr. Mukti Ganguly as Professor in Special Education under aegis of School of Education at Kalyani Regional Centre, NSOU on purely temporary basis as full time dedicated Faculty for a period of 1 (one) year subject to periodic renewal by the appropriate authority with effect from the date of her joining. Her consolidated pay is fixed at Rs. 60,000/- (Sixty- Thousand) per month only.
