NOTIFICATION

Whereas as per the UGC-DEB mandate [vide their F.No.9-4/2018(DEB-III); dated 16th August, 2018], it has come an absolute necessity to fill-up the vacant sanctioned posts of teaching faculties on exigent basis.

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Dr. Chittaranjan Sarkar as a Professor in Commerce under aegis of School of Professional Studies, NSOU on purely contractual basis as full time dedicated for a period of 3 (three) months (renewable) from the date of his joining. His consolidated monthly pay will be fixed at Rs.75, 000/- (Rupees seventy five thousand) only.
