NOTIFICATION

Whereas as per the UGC-DEB mandate [vide their F.No.9-4/2018 (DEB-III); dated 16th August, 2018], it has become an absolute necessity to fill-up the vacant sanctioned posts of teaching faculties on exigent basis.

And whereas, it is not possible at this moment to engage a Professor afresh against an existing sanctioned post as recruitment is under process

And whereas, the Vice-Chancellor has been empowered by the Executive Council to engage temporarily against any sanctioned posts from retired personnel having required qualification,

And whereas, the Vice-Chancellor is the appointing authority according to Para no.25A of the West Bengal Act XII of 2011 (published on 25.01.2012),

And whereas, Dr. Sibaprasad De, a retired Principal in Education (in WBSES) of Government College of Education, Burdwan (Retired on 31.03.2022 & D.O.B on 18.03.1957) has applied before the Vice Chancellor to be considered to engage as a Professor in Education in this University,

And whereas, Director, School of Education, NSOU has recommended to engage Dr. Sibaprasad De as a Professor in Education

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Dr. Sibaprasad De as a Professor in Education under aegis of School of Education, NSOU on contractual basis as full time dedicated Faculty for a period of 3 (three) months (renewable) from the date of his joining. His consolidated monthly pay is fixed at Rs. 75,000/- (Seventy-five Thousand) per month only.
