## **NOTIFICATION**

Whereas as per the UGC-DEB mandate [vide their F.No.-9-4/2018 (DEB-III); dated 16<sup>th</sup> August, 2018], it has become an absolute necessity to fill up the vacant sanctioned posts of teaching faculties on exigent basis.

And whereas, it is not possible at this moment to engage a/an Assistant Professor/ Associate Professor/ Professor afresh against existing sanctioned posts, in view of the UGC letter No. F.1-5/2006 (SCT) dated 19.07.2018.

And whereas, the Vice-Chancellor has been empowered by the Executive Council to engage temporarily against any sanctioned posts from retired personnel having required qualification.

And whereas, the Vice-Chancellor is the appointing authority according to Para no.25A of the West Bengal Act XII of 2011 (published on 25.01.2012),

And whereas, Prof. Himadri Lahiri, a retired Professor in English from the University of Burdwan (retired on 30.09.2016) has applied before the vice Chancellor to be considered to engage as a Professor in English,

And whereas, Director, School of Humanities, NSOU has recommended to engage, Prof. Himadri Lahiri as a Professor in English,

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Prof. Himadri Lahiri as a Professor in English under aegis of School of Humanities, NSOU on purely temporary contractual basis as full time dedicated Faculty for six months from the date of his joining. His remuneration will be fixed as consolidated one either to be calculated on the basis of last pay drawn less Basic Pension plus admissible allowances on such pay. Other entitlements will be as per existing rules/norms of the University or as may be framed from time to time.


