- c) You will be required to produce release order from your present employer before joining the post and also to produce the last pay certificate from the employer – where applicable.
- d) You will be on-probation ordinarily for a period of not less than one year from the date of joining at NSOU. Your confirmation in the post shall depends on satisfactory work and conduct during the period of probation.
- e) Your service will be governed by the relevant provisions of the extant Act, Statutes, Ordinance, Regulations and Rules of the NSOU read with the respective amendments as may be issued from time to time.
- f) You shall also be guided by the relevant terms and conditions as laid down in the relevant orders of the State Government and any other order(s) which may be issued by the State Government from time to time and as accepted by the University.
- g) You will be due to superannuation on attaining the age of 65 years or as may be decided by the State Government from time to time and as accepted by the University.
- h) You will not accept any other employment with or without remuneration except the permission of competent authority.
- You will be posted at the Regional Centre, Jalpaiguri, of the University until further order.
- j) You are liable to be transferred to any Campus/Regional Centre of the NSOU as may determined by the Vice-Chancellor and/or the competent authority, as and when required.
