### NOTIFICATION

Whereas as per the UGC-DEB mandate [vide their F.No.-9-4/2018 (DEB-III); dated 16<sup>th</sup> August, 2018], it has become an absolute necessity to fill up the vacant sanctioned posts of teaching faculties on exigent basis.

And whereas, it is not possible at this moment to engage a/an Assistant Professor/ Associate Professor/ Professor afresh against existing sanctioned posts as recruitment is under process.

And whereas, the Vice-Chancellor is the appointing authority according to Para no.25A of the West Bengal Act XII of 2011 (published on 25.01.2012),

And whereas, Dr. Sital Prasad Nag, a retired Associate Professor in Political Science and Public Administration from West Bengal Education Service retired on 31.01.2016, has applied before the Vice-Chancellor to be considered to be engaged as an Associate Professor in Political Science,

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Dr. Sital Prasad Nag as an Associate Professor in Political Science under aegis of School of Social Sciences, NSOU on contractual basis as full time dedicated faculty for six months from the date of his joining. His remuneration will be fixed as consolidated one to be calculated on the basis of last pay drawn less Basic Pension plus admissible allowances on such pay. Other entitlements will be as per existing rules/ norms of the University or as may be framed from time to time.
