NOTIFICATION

Whereas as per the UGC-DEB mandate [vide their F.No.-9-4/2018 (DEB-III); dated 16th August, 2018], it has become an absolute necessity to fill up the vacant sanctioned posts of teaching faculties on exigent basis.

Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Dr. Utathya Bandyopadhyay as a Professor in Political Science under aegis of School of Social Sciences, NSOU on purely temporary contractual basis as full time dedicated faculty for six months from the date of his joining. His remuneration will be fixed as consolidated one either to be calculated on the basis of last pay drawn less Basic Pension plus admissible allowances or Rs. 75,000/-whichever is less.
