Therefore, as approved by the Vice Chancellor the undersigned is directed to engage Dr. Kumkum Sarkar as an Associate Professor in Sociology under aegis of School of Social Sciences, NSOU on purely temporary contractual basis as full time dedicated faculty for six months from the date of her joining. Her remuneration will be fixed as consolidated one to be calculated on the basis of last pay drawn less Basic Pension plus Admissible allowances on such pay. Other entitlements will be as per existing rules/norms of the University or as may be framed from time to time.
