4. To report the progress of data collection and compilation for the Annual Quality Assessment Report (AQAR-NAAC) and NSOU Annual Report for 2022-23. ([Annexure-2](#))

Most of the data have been received by the CIQA from different departments/ Schools. All the members present were requested to submit the remaining data in the prescribed template of AQAR within 30/11/2023 (already resolved in the 3rd meeting of the Working Committee held on 7/11/2023). Dr. Papiya Upadhyay, Asst. Professor, Education has been given the addl. responsibilities to help CIQA for the submission of NAAC-AQAR and Annual CIQA report etc. Dr. Premananda Jana, RD-Kalyani was requested to send the credit pages of all SLMs (UG and PG) from the printers. The office of the Director, Study Centres may request the printers to send the said pages to the Director, RC-Kalyani for onward transmission to CIQA within 8th December 2023.

5. To review the progress of the University funded projects (2021-22) and to consider new project proposals of the faculty members.

It was reported that to date the CIQA has received the intimation of submission of the UC and report to the appropriate authority by eleven faculties (Annexure-A). It was resolved that all the UC of the present projects (2021-22) may be audited centrally by the Finance Department for those who could not submit the audited UCs. Henceforth, the Finance Department may take the responsibility to get the UC audited by a qualified Chartered Accountant. The fund may be released to each PI after deducting the audit fees of Rs.2000/-. On completion of the audit and certification from the Finance Officer, the Registrar may issue the Completion Certificate to the PI with a copy to CIQA for the purpose of NAAC. The PIs may deposit the unspent money of the existing projects to the university by 15th December 2023 to make the project account zero balance.

The CIQA may invite proposals for research projects for the financial year 2024-25 from the faculties in the prescribed format as per NSOU Project guidelines. The faculties may submit their proposal duly forwarded by the Head of the Schools from 15th December 2023 to 15th January 2024. The submitted proposals by the respective PIs will be placed in the duly constituted Project Selection Committee (as prescribed below) for screening of the project proposals where the PIs may be invited to defend their proposal.

Project Selection Committee (PSC):

- i) Director/ Officer-in-Charge of the School/ - Chairperson*
- ii) One External Subject Expert- not below the rank of Professor*
- iii) Director, CIQA- Convener*

Where the Head of the School is the PI, the Vice-Chancellor may nominate one professor as the chairperson of that particular Project Selection Committee (PSC).

The recommendation of the PSC may be placed in the Research Advisory Committee (RAC) of the University for ratification.

6. To report the collaborative project with the National Institute of Educational Planning and Administration (NIEPA). Project title: Integrating Digital Technology with Teaching and Learning in Indian Higher Education ([Annexure--3](#))

The duly constituted Academic-Administrative Committee (Annexure A) recommended the revised Quality Assurance System (QAS) for the university. The House unanimously accepted the document and approved it.

The House appreciated the efforts taken by the members of the Working Committee to prepare the proposal for the sponsored seminar titled “Contextualizing NEP 2020: Quality Initiatives in Restructuring Higher Education”. Now the CIQA may send the proposal to NAAC for their consideration.

10. To consider the restructuring of the NSOU web portal for faculty log-in to upload their publications and other information as per requirements of NAAC/ UGC. A separate TAB may be incorporated for the LSCs to upload the details of Academic Counsellors by them with user ID & PW for UGC and NAAC.

The due date for submission is 28/11/2023 as per the UGC reminder mail dated 24/11/2023.
