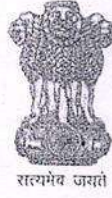

Madam/Sir,

AICTE has taken decision to give NOC for the period of five years for the eligible Universities/ Institutes in respect of ODI./ Online courses for the Universities/ Institutes offering such courses.

In case of Universities/ Institutes who have already been issued NOC for the AY 2022-23 and willing to have NOC from AICTE up to A.Y. 2027-28 may get it issued by depositing requisite fees for remaining years to the AICTE.
