Please refer to your proposal no. SOE/161/2023 dt. 29th May, 2023 on the subject cited above and directed to inform you that the Council has no objection for granting permission to conduct M.Ed. Spl.Ed.-ODL (HI & IDD) course at Netaji Subhas Open University, Kolkata for one academic sessions i.e. 2023-24 subject to the condition that prescribed norms are fulfilled and maintained throughout the course. Details of the same are as under:

Course	Duration of the course	Intake capacity
M.Ed. Spl.Ed.(HI)-ODL	Two & half years (2 ½) (05 Semester)	30
M.Ed. Spl.Ed.(IDD)-ODL	Two & half years (2 ½) (05 Semester)	30

- As per the MoU with NSOU, admission as well as examination of above said course shall be conducted by the University in accordance with their ordinance. However, the Council shall reserve the right to monitor the standard of the training course by deputing a team of experts during the period of contact classes and examinations at the University.
- The NSOU, Kolkata will be responsible for admission procedures, enrolment of the eligible candidates, commencement of the academic session, period of the contact classes, examination schedule, award of degree etc.
- In case of violation of the RCI norms in respect of the above mentioned training course, the Council may take appropriate action and discontinue the course at the University.
- NSOU, Kolkata is advised to submit a copy of UGC-DEB approval, prior to start the M.Ed.Spl.Ed.-ODL (HI & IDD) Course.
- Approval fee of Rs. 30,000/- per year/ batch for each course may please be remitted to the Council in the form of demand draft favouring Member Secretary, RCI payable at New Delhi.
