Agenda Note: For Setting up of Regional Centres(RC) at Jalpaiguri on a piece of land measuring 2.87 acre and at Durgapur on a piece of land measuring 5 acre, the University approached the chief engineer, social sector P.W Directorate Govt. of W.B. to prepare the project estimate and to execute the construction work. The proposal was accepted by the Chief Engineer social sector P.W Directorate. Both the project estimates received Administrative Approval of the Higher Education Deptt by the middle of July 2014. The Social Sector P.W. Directorate soon took up the implementation of both the project work. Some members of the Building Committee formed by the University as per statute, visited the sites of both Durgapur and Jalpaiguri in the month of November'15. The progress of work of both the places appear satisfactory. It is expected that the construction of Faculty Building, Administrative Building and Guest House at Jalpaiguri and at Durgapur will be completed by the middle of this calendar year 2016.

A piece and parcel of land at New Town, Kolkata was received by the university measuring three(3) acres, from HIDCO for establishing a regional centre and open campus of NSOU under the principal use "education". The agreement of deed was signed on 14.10.2015. Recently it has been informed by the Higher Education (HE) Deptt that the stamp duty and Registration fees chargeable on the execution of Lease Deed in respect to this land has been remitted.]

To prepare a project report for setting up of a centralized campus at New Town an expert committee has been formed as per recommendation of the Building Committee. A meeting of this committee was held on 22.02.2016 in the chamber of Vice-Chancellor, NSOU. At the outset the Vice Chancellor apprised the members the objective of forming a committee of experts to advice about the steps to be taken for the proposed construction of a regional centre and open campus at New Town. The committee looked into the list of state bodies and corporations as per rule 47D of FD5400-F(Y); dated 25.06.2012 as forwarded and advised by the Higher Education Department. Competence and limitations of the bodies and corporations to do all the functions like PWD was also briefly discussed. The committee felt that for assigning the work to Public Works Dept. or other bodies, a proper concept document with general arrangement needs to be prepared first to enter into an agreement/MoU. Since the University is not having any set up to prepare a proper technical concept document, it was felt that services of a competent consultant may be availed in this regard.

19. To consider a report on the functioning of the Kalyani, Campus.

Agenda Note: All the Schools of Studies have been allotted adequate space in the Kalyani Campus to conduct their diverse academic programmes. Most of the Schools have been provided financial assistance to develop infrastructural facilities to set up smart classes, laboratories, PCP(Personal Contact Program) arrangements with full ICT support in addition to SLMs (Self Learning materials). An audio visual (AV) studio is also to be set up soon to cater to the needs of the students.] Space has been allotted for organising activities of the Central Library of the University at Kalyani campus, under the control of Deputy Librarian. Total area measuring about 2194sqft(approx) on the second floor of the newly constructed three storied warehouse building at Kalyani Campus has been allotted for this purpose

- 20. To consider the matter 14-Non-Teaching employees (Annexure- F)
- 21. To report on the on-going litigation [SLP (C) 8497-98 of 2015 & SLP (C) of 13663 of 2015] at the Supreme Court of India regarding validity of NSOU's Ph.D. Degree



Agenda Note- Order dated 24.12.2014 of arising out of MAT 1068 of 2014 with CAN 9459 of 2014 relating to the case of Dr Abdul Motin –vs- Dr Manisankar Maity.

In the proceedings of the aforesaid litigation in the Division Bench of High Court, Calcutta the Ph D degree of NSOU was mentioned as "substandard and not up to the mark". Not only that all the degrees in comparison to its equivalent counter-parts of regular university has been stated as substandard. The matter is now pending before the Hon'ble Supreme Court of India and NSOU is one of the defendants.

22. To report the Court case regarding the post of Co-ordinator, B.Ed. (SEDE)-R.V.W No 84 of 2015 & CAN 3744 of 2015 (A.Panigrahi Vs NSOU & Others).

Agenda Note- As per the last communication from the Advocate of Shri Partha Sen that after hearing the parties High Court, Calcutta has dismissed the above stated Review Application. And at the same time Advocate of Shri Panigrahi intimated the University that very soon they are going to file SLP at Hon'ble Supreme Court and advised the University "to refrain from going ahead with any immediate appointment for the aforesaid post in favour of Sri Patha Sen or anyone else". It is pertinent to mention that the Process of Selection for the Post of Co-ordinator B.Ed (SEDE) was held on 16.07.2010. Selection committee made a single member panel consisting of Shri Partha Sen. But before issuance of appointment letter to Shri Sen, Shri Abhedananda Panigrahi (one of the candidates) challenged the selection of Shri Sen in the court of law on the ground that Shri Sen was having inadequate experience at that material point of time.

Reference for discussion- The process of selection of candidate for the post of Co-ordinator, B.Ed (SEDE) was held on 16.07.2010 and nearly four and a half years have lapsed as it was held up in the courts of law (both High Court and Supreme Court. No appointment letter has been issued till date. The present E.C was constituted in 2012 and the aforesaid selection process has never been reflected in any deliberation(s) of the present EC. Meanwhile as per latest RCI stipulations the B.Ed-ODL(SEDE) course structure and contents have been thoroughly revised.

- 23. To propose a suitable date and venue for holding of 10th annual convocation of the University for approval by the Hon'ble Chancellor.
- 24. To authorise the Vice-Chancellor to implement different orders as may be issued by the Govt. of West Bengal for the University from time to time in connection with service conditions such as promotion, leave rules, CAS etc for Teachers, Officers and Non-Teaching employees.

Accordingly a meeting was held on 05.08.2015 to deliberate on the matter concerned. All the Directors/ OICs/ Heads of departments deliberated on the matter at hand and accordingly details as sought by the H.E Deptt regarding proposed services to be rendered by the university were forwarded to the H.E Deptt.
- 2. To consider matters related to extension of benefits viz. emoluments, security of tenure, Group Health Insurance Scheme (Swasthya Sathi) and certain terminal benefits in favour of the casual/ daily rated/contractual workers of the University, given their concern consequent to the issuance of some recently issued G.Os of the Finance Dept. GoWB (vide no. 1107-F(P) Dt. 25.02.2016 & 1104-F(P) Dt 25.02.2016). The Vice Chancellor has sought the opinion of the Govt. in the Dept of H.E., University Br. (vide his letter no. VC/ 169; Dt. 29/02/2016) regarding implementation of these orders.
- 3. To report on the constitution of Internal Quality Assurance Cell (IQAC) [vide Memo No. Reg/588, Dt. 12.08.2014] and its activities.
 - Agenda Note: Two meetings of the Cell were held on 10.11.2014 and on 06.01.2016. Relevant parameters for new appointments, promotions under CAS and re-employment of faculties of the University were decided vide Minutes of the first meeting of the IQAC held on 10.11.2014. Proceedings circulated in advance and the same was confirmed in the meeting.

2. To report the actions taken in pursuance of the resolutions adopted in the 69th meeting of the Executive Council held on 08/02/2013.

Report of 'Action Taken' circulated in advance and was confirmed in the House.

3. To report about the joining of Prof. Subha Sankar Sarkar as the Vice-Chancellor of the University on recommendation of a duly constituted Search Committee for a term of 4(four) years w.e.f. 16/09/2013 (F.N).

Registrar reported and the V.C was congratulated for his appointment. The House congratulated the V.C for the initiative, he took and leadership he gave during his tenure of officiating appointment for regularizing the backlog in the examinations and other matters and hence ensuring smooth running of the University with the support of the members of his team of faculties, officers and all categories of staff.

4. To report on the Meeting of a Special E.C. on 17/08/2013 exclusively with single agendum of organizing the 9th Convocation of the University on 30th Sept., 2013 as per the advice of the Hon'ble Chancellor.

Vice-Chancellors reported about the holding of the 9th convocation and it was noted.

5. To report about the proceedings of the 34th meeting of the Academic Council held on 20/12/2013.

Reported with the following notes:

- (i) Item no. 11 was accepted in principle and it was advised that when UGC guidelines will come into force, the proposed rules should be modified, if necessary, in compliance with the UGC guidelines.
- (ii) Regarding item no.13 Prof. H.P.Dikshit expressed his reservation in affiliating Private Institution(s) for offering degree & P.G. Diploma. However it was decided that in every respect the academic programmes of the University will be in keeping with the guidelines of the UGC in the context of ODL.
- (iii) Item no. 17 was accepted and it was advised that endeavor should be taken to increase the seats by launching the courses in additional study centres so that meritorious students without Honours Degree may also get the chance for pursuing Post Graduate Degree.
- (iv) Regarding item no. 19 it was felt that the term 'Grace Mark' appears to be disgraceful and hence instead of awarding grace mark V.C. is empowered to moderate the result for the stated purpose.
- (v) Regarding 'Assignment Marks' in item no. 22 it was proposed that A.C may reconsider implementing the method of procuring the Assignments along with the TEE Answer Scripts of theoretical papers.
- 6. To approve the draft Ph.D. rules, already approved by the A.C. in its 34th meeting.

[Agenda Note by Prof. H.P. Dikshit: "About the agenda item for Ph. D. degree Ordinance I would request you to place the following facts and recent developments on this issue before the authorities of the University.

- (i) Sometime ago the UGC had issued a notification for not recognizing Ph. D. degrees awarded through DE system.
- (ii). As you know, DE Bureau of the UGC now deals with DE. In a recent report of a high power Committee to frame Guidelines for DE System in the Country appointed by the UGC. There was quite some debate in the Committee about not including Ph. D. Programmes through DE. Finally, it was decided to include the provision for Ph. D. through DE in the Report.
- (iii) The report has been considered by the Commission in its last meeting.
- (iv) It may be useful to wait for the decision of the UGC on the matter.

I have two meetings in the UGC on 21/1/14, one of which concerns DE and would try to get a copy of the guidelines if finalized by them."]

Deliberation in detail took place, it was reported by Professor Dikshit that in the present context the UGC guideline on ODL system is in final stages of development and it was resolved that as soon as it would be notified the same would be incorporated and implemented by the University and be reported to the next E.C.

7. To report about the proceedings of the 26th F.C held on 07/12/2013

Réported and approved.

8. To report the shifting of the major administrative wings of the University to the newly constructed Administrative Campus of the University at DD 26 in the Salt Lake City, Kolkata-64.

[Agenda Note: The construction of a G+6 storied urban campus of NSOU on plot no. DD 26 at Salt Lake, Kolkata is almost completed by KMDA. Finishing work is in progress. Bidhannagar Municipality has already provided ferrule connection for water supply and also working for sewerage connection to the building. Power supply to the building is also granted by Chief Electrical Inspector, Directorate of Electricity. For furnishing the building University has already moved with an estimate to the Higher Education Deptt. for granting permission and allotment of fund for purchase of office furniture for the said building at a cost of Rs.1,19,72,766.81 (estimate prepared by Godrej & Boyce Co. as per our requirement). University is expecting to move to the said building latest by 31st March, 2014 after furnishing the building with office furniture.]

Reported and noted down.

9. To report the initiatives to develop Regional Centres of the University at Jalpaiguri, Durgapur and Rajarhat with the help and support of the Government of West Bengal.

[Agenda Note: It is our pleasure to inform the house that the Govt. of West Bengal has allotted in favour of our University two pieces of land one at Jalpaiguri measuring 2.87 acres another at Durgapur measuring 5 acres, in addition there are probability of getting another piece of land at Krishanpur, Rajarhat mauza measuring 3 acres, all are for establishing our regional centre in each of the place. It is thought for some time past that if University can approach directly to the educational Institution/consulting firm or state Govt./central Govt. agencies regarding preparation of master plan and DPR elaborating the scope of work with specification and estimate based on approved architectural and structural drawing prepared by them.

Tendering and implementation of plan may be done by the University itself by engaging agency through competitive bidding/tender amongst the state agency/ central agency/ consulting firms. A set up of retired Engineers of SAE/AE rank and one retired executive engineer of the Govt. / Quasi Govt. engineering department may be engaged for getting technical checkup and overall vigilance. The whole process will be performed under the umbrella of a building committee consisting of Vice Chancellor as Chairperson of the building committee, Registrar as convener, Finance Officer and Director of Study Center, Directors of Schools of Studies and three engineers from Govt. department and educational Institution.

Executive Council may consider to empower VC to form a building committee in accordance and to go for outsourcing for preparation of DPR of the project and to implement the project through competitive tender amongst the state agency/central

agency/consulting firm by deploying on contract basis a skeleton infrastructure of two sub-assistant engineer and one executive engineer from the retired persons.] In addition to the above agenda note it is to be added further that the Industry Institute Partnership Cell of Jadavpur University has already prepared a Detailed Project Report and a forecast estimate for our proposed Regional Centres at Durgapur and Jalpaiguri which are going to be submitted shortly to the Govt. for administrative approval and allotment of fund.

Reported and noted down.

10. To consider modification of the resolution of the 69th EC Meeting (Agenda No 11) regarding extension of the past service benefits to Professor Debnarayan Modak to include the service rendered by him at Nabadwip Vidyasagar College, Nadia, from 01.03.1983. to 30.06.1992 against substantive position.

[Agenda Note: Professor Modak served Nabadwip Vidyasagar College, Nadia, from 01.03.1983. to 30.06.1992 against substantive position. His service books and other relevant papers in this respect had also been forwarded by his previous employer. Inadvertently, the matter has not been incorporated in the resolution of the 69th EC Meeting. Now it is proposed to incorporate through modification of the said resolution.]

8. To report the shifting of the major administrative wings of the University to the Newly constructed Administrative Campus of the University at DD 26 in the Salt Lake City, Kolkata -64

The G+6 storied urban campus at DD-26, Sector-I ,Salt Lake was inaugurated by the Hon'ble MIC, Deptt of Higher Edn. and Hon'ble MIC, Deptt.of Municipal affairs & Urban Development, GoW.B. on 1st March 2014. Immediately the day after the inauguration NSOU started shifting its establishment in phases from 1, Wood burn Park, Kolkata- 700020 to its present location. This was done in haste because of the directive of the State Government even though electrical and related infrastructural work (including installation of the elevator, 320 KVa diesel generator and fire safety system by the KMDA (the implementing agency) was completed much later only in September - 2015. On date the G+6 storied Urban Campus is more or less complete. The furnishing work of the building has been done with the allotment of fund received from Higher Education Department. However, the final approval of the Bidhannagar Municipality (the local civic body) with regard to the Completion Certificate is still pending in spite of repeated correspondences with the KMDA and Bidhannagar Municipality.

9. To report the initiatives to develop Regional Centres of the University at Jalpaiguri, Durgapur and Rajarhat with the help and support of the Government of West Bengal.

For Setting up of Regional Centres at Jalpaiguri on a piece of land measuring 2.87 acre and at Durgapur on a piece of land measuring 5 acre, Netaji Subhas Open University approached the Chief Engineer, Social Sector P.W Directorate Govt. of W.B. to prepare the project estimate and to execute the construction work. The proposal was accepted by the Chief Engineer, Social Sector P.W Directorate and made available the project estimate within a few days. Both the project estimates received administrative approval of the Higher Education Department, GoWB by July- 2014. The Social Sector P.W. Directorate soon took up the implementation work of both the projects.

The Building Committee as formed by the University in terms of Clause 17.(1) of Statutes (Revised), 2014 is overseeing the progress of these projects and related matter.

Be it noted that though the Industry Institute Partnership Cell of Jadavpur Universty prepared and submitted a forecast estimate of the aforesaid projects, due to some technical problems arising out of F.D Notification No 5400 F(Y), Dt. 25.6.2012, the same could not be proceeded with.

3. Rationalization of Financial Support to Study Centres:

Dr. A. B. Aich, Director of Study Centre, placed the proposal for rationalization of financial support to the study centres offering BDP courses before the Finance Committee for necessary consideration. The F. C. Committee observed that while the Course fees for all courses were going to enhance, the financial support to the study centres might be enhanced on rational basis and the F. C. had approved rationalization of support to the study centres offering BDP courses in the following line:-

- (1) Existing Remuneration be hiked @ 25%
- (2) Existing Counselling fees be hiked @ 25%,
- (3) Existing Contingencies be hiked @ 100%.

In tune with this change in respect of BDP courses, a similar rationalization is naturally called for PG courses as well. The F. C. approved the enhanced rationalization for different categories which were stated below.

- (A) Existing Remuneration of the staff of the PG lab-based centres be hiked by 25%,
- (B) Existing Remuneration of the Academic Coordinator for PG PCP be hiked by 25%,
- (C) Sharing of PG admission Fees be hiked from the current Rs. 200/- per student admitted to Rs. 300/- per student admitted.
- (D) Existing Contingencies given to the PG lab-based centres be hiked by 100%.

It may be mentioned here that there are only seven study centres conducting PG lab-based courses.

Report for Purchase of Furniture from Godrej & Voyce Mfg, Co. Ltd:

The Finance Officer reported that on the basis of written request to HE Department to sanction fund amounting to Rs. 1,10,00,000/ for procurement of furniture & fittings in New Administrative Building located at DD - 26, Sector - I, Salt Lake City, Kolkata - 700064, the HF Department was pleased to sanction an amount of Rs. 90,00,000/ for the stated purpose. - Confirmation of the Minutes of 27th Finance Committee Meeting held on 24th May, 2014:
 The Minutes of 27th F.C. meeting was read out by the Finance Officer and was confirmed & signed by the Hon'ble Vice-Chancellor with a note that the decision taken under the agenda for Revision of Course Fees and Other Fees was not ultimately implemented.
- Placement of Budget for FY 2015-16:
 Shri Kar, F.O., placed the Budget segregating specifically all divisions under Non-Plan Budget and Plan Budget Head of A/c for the Financial Year 2015 16 along with the Revised Budget for the Financial Year 2014 15 for approval. The Budget was duly approved without any modifications.
- 3. Construction of two Regional Centres (RCs) at Durgapur & Jalpaiguri:

 It was deliberated on whether the University Authority could give undertakings to the "Social Sector, Public Works Directorate, GoWB" entrusting the whole construction works of the said two RCs whereas the HE Dept., GoWB had already sanctioned 3 crores for each of the two Regional Centres against cost as per DPR Rs. 7.48 Crores for Durgapur and Rs. 7.308 Crores for Jalpaiguri in absence of the Administrative Approval of the Govt. for the said two RCs. Sri Debasis Datta, Deputy Financial Adviser of HE Dept., requested the Vice-Chancellor to take up the matter to HE Dept. forthwith for Administrative Approval on the basis of which the University Authority could give the said undertakings to the Social Sector, Public Works Directorate, GoWB. Accordingly, for the entire work of the two Regional Centres the Social Sector, Public Works Directorate, would be able to go for Tender separately for each RC. Sri Datta also assured the house that on receipt of proposal, he would take all possible steps so that the Administrative Approval could be issued at the

earliest. The V.C. in his turn assured the House that the University Authority would send the request to HE Dept, for the same as soon as possible.

4. Advice regarding status of 14 Non-Teaching Staff (Gr. C+D):

The Registrar raised the matter relating to the Memo. No. 621 –Edn(U)/EH/O/1U-62/98; Dt. 16th June, 2014 issued by Smt. Madhumita Roy, IAS, Additional Secretary, HE Dept, wherein it was pointed out that the HE Dept, would not refer the case of regularization of the services of 14 employees of NSOU to the Finance Dept. of W. 8. as they were recruited and confirmed in the absence of any recruitment rules, sanctioned posts, any selection procedure and approval of the State Govt. and decided to withdraw budgetary support towards payment of salary of those 14 employees. Sri Datta opined that since the G. O. was issued in terms of the section 51 of the NSOU Act, 1997 and the W. B. Universities (Control of Expenditure) Act, 1976 the University Authority had no other option but to go by G.O. In the circumstances it has been resolved that the matter may be placed before the next EC for deliberation.

5. Courier Charges of Tripti Courier Service:

The Registrar reported that the Tripti Courier Service regretted not to deliver materials to Study Centres of B. Ed. (ODL) which were located to remote and backward areas at the existing rates. The Registrar proposed whether the existing rates could be increased for the said Study Centres. It was resolved that the University should go for tender as per rules of the State Govt, as there were more than 2 years elapsed, pending which the existing system may continue. The House accepted the opinion.

6. Application of Empanelled printers for Extension of terms for next two years: The Finance Officer reported that 7 empanelled printers submitted an application requesting the Vice-Chancellor to extent the period by more two years at the same terms and conditions which were fixed on 13th August, 2013 through open tender. It was resolved that the University should go for selecting printers for the University for next two years though open tenders as per Govt. Rules as soon as possible.

7. Missing of Laptop HP Pro Book:

The Registrar reported that the Laptop HP Pro Book No: 2CE027050J, issued on 21-09-2010 in favour of Smt, Tinki Kar Bhattacharya, Asstt. Prof. of Geography, NSOU, was missing from her residence on 16-06-2014. Smt. The Civil work at Jalpaiguri has advanced to the tune of 35%. The House advised the University Authority to place requisition for the balance amount of the administrative approvals for the two RCs in 2015-2016.

4. Report on status of 14 Non-Teaching Staff (Gr. C & D):

The Hon'ble Vice Chancellor briefed the matter retaining to 14 Non-Teaching Staff of this University for whom the budgetary support has been withdrawn by the HE Deptt (i.t.o. its Memo No. 621-Edn(U)/EH/O/1U-62/98: Dt. 16/05/2014). 4. To consider the matter related to obtaining recognition under section 12(b) of the UGC act 1956(as it is now impending in connection with the DEB-UGC grants).

[Agenda Note: Regarding obtaining recognition under section 12B of the UGC Act, 1956, NSOU like most other State Open Universities (SoUs) have taken measures to gain eligibility to seek recognition from UGC under 12B in the light of the fact that UGC-DEB has discontinued financial assistance to the university w.e.f 2015-16 F/Y due to lack of 12B recognition. Furthermore like most other State Open Universities (SoUs) NSOU, has appealed to UGC/MHRD for relaxation of the norms therein. Formal applications have already been made to the GoWB to sanction some additional posts for teachers, officers & Non Teaching staff, as well as infrastructural augmentation at the Kalyani Regional centre campus. This has been done to enable us to comply with the UGC guidelines/mandate on minimum requirements to obtain 12-B status. With regard to financial support, some of the needs, i.e in infrastructural matters, grants have been received from the State Government. We have already initiated infrastructural development in the Kalyani campus with setting up of smart classrooms, laboratories and AV studio with ICT support. Now, we are awaiting the sanction of the HE Deptt, GoWB, for the additional posts in the different categories. Meanwhile, we have already started the process of completing the proforma/application to UGC for 12-B recognition, along with necessary backup papers and the same would be sent to UGC as soon as feasible.]

Reference is invited to Office Letter No. F.No. DEC/NSOU/KKT/WB/09/1184-1187 dated 21.08.2013 (copy enclosed) conveying the approval of the University Grants Commission (UGC) to your University for offering programmes in Open & Distance Learning (ODL) mode. In this regard, I am directed to inform that the UGC has taken decision to maintain status quo for 2014-15 and accordingly the recognition/approval granted to you vide the aforementioned letter would continue for academic year 2014-15. Your University may offer the programmes in ODL mode which were approved by the statutory body/ies of your University and were offered during 2013-14 in accordance with approval conveyed by UGC.

- 2. The above recognition is subject to the following terms and conditions:
 - i) The University shall offer only those programmes through distance mode which are approved by the statutory bodies of the University as per norms and wherever necessary by the Apex regulatory bodies of the country.
 - ii) It is the responsibility of the University to follow the norms prescribed by the concerned regulatory body/ies such as UGC/AICTE/any other, and also seek its/their prior approval, wherever required, for any specific programme mentioned above.
 - iii) Nomenclature of all programmes shall be as per UGC/AICTE.
 - iv) No teacher education programmes can be offered without prior approval of the NCTE.
 - v) Programmes in physiotherapy are not allowed through distance mode.
 - vi) University shall refrain from offering such programmes that are not allowed to be offered through distance mode by respective apex body/ies.
 - vii) MHRD directions prohibiting B.E. / B. Tech. through Distance mode vide its letter dated 29/07/2009 shall be adhered to strictly (copy at UGC website).
 - viii) The eligibility conditions for admissions will be as per UGC/AICTE norms.
 - ix) The minimum duration of a programme offered in ODL mode should not be less than the minimum duration of similar programme offered through the regular mode.
 - x) The University has at least one full time faculty member exclusively for coordinating each programme at the headquarters.



- xi) The territorial jurisdiction in respect of Universities for offering programmes through distance mode will be as per the policy of UGC on territorial jurisdiction and opening of off campuses/centres/study centres as mentioned in the UGC Notification No. F. 27-1/2012 (CPP-II), dated 27th June 2013, a copy of which is also posted in the UGC website www.ugc.ac.in/deb. In respect of standalone Institutions (other than the Universities), the territorial jurisdiction will be headquarters.
- xii) Franchising arrangement for offering programmes in distance mode in any form is not allowed.
- 3. The Institution's management of the distance education programmes will be open for review and inspection by the UGC. The academic norms of the programmes shall be under monitoring by the concerned regulatory authorities.
- 4. Before launching the programme/s, the Institution shall submit an affidavit within 30 days from date of issue of this letter that it agrees to and will abide by all terms and conditions contained in letter referred to in para 1 above and the terms and conditions laid down in para 2 above. In case the UGC does not receive the affidavit within 30 days from the date of issue of this letter, the approval accorded to your Institution will be liable to be withdrawn. It may also be noted that:
 - i) If the institution fails to comply with the conditions of recognition or if it is found conducting affairs in a manner that leads to deterioration of academic standards, the UGC may withdraw its recognition.
 - ii) In case any information, documentary evidence submitted/produced by the University/institution is found to be false or fake at a later stage, the recognition of University/institution shall be withdrawn and the University/Institution concerned shall be solely responsible for the career of the students enrolled.
- 5. Your University is required to send along with the affidavit, a list of programmes (approved by the statutory bodies) that are on offer through distance mode currently, duly authenticated by the Registrar.

18. To report on the development of Regional Campuses of the University including the Rajarhat Campus

Agenda Note: For Setting up of Regional Centres(RC) at Jalpaiguri on a piece of land measuring 2.87 acre and at Durgapur on a piece of land measuring 5 acre, the University approached the chief engineer, social sector P.W Directorate Govt. of W.B. to prepare the project estimate and to execute the construction work. The proposal was accepted by the Chief Engineer social sector P.W Directorate. Both the project estimates received Administrative Approval of the Higher Education Deptt by the middle of July 2014. The Social Sector P.W. Directorate soon took up the implementation of both the project work. Some members of the Building Committee formed by the University as per statute, visited the sites of both Durgapur and Jalpaiguri in the month of November 15. The progress of work of both the places appear satisfactory. It is expected that the construction of Faculty Building, Administrative Building and Guest House at Jalpaiguri and at Durgapur will be completed by the middle of this calendar year 2016.

A piece and parcel of land at New Town, Kolkata was received by the university measuring three(3) acres, from HIDCO for establishing a regional centre and open campus of NSOU under the principal use "education". The agreement of deed was signed on 14.10.2015. Recently it has been informed by the Higher Education (HE) Deptt that the stamp duty and Registration fees chargeable on the execution of Lease Deed in respect to this land has been remitted.]

To prepare a project report for setting up of a centralized campus at New Town an expert committee has been formed as per recommendation of the Building Committee. A meeting of this committee was held on 22.02.2016 in the chamber of Vice-Chancellor, NSOU. At the outset the Vice Chancellor apprised the members the objective of forming a committee of experts to advice about the steps to be taken for the proposed construction of a regional centre and open campus at New Town. The committee looked into the list of state bodies and corporations as per rule 47D of FD5400-F(Y); dated 25.06.2012 as forwarded and advised by the Higher Education Department. Competence and limitations of the bodies and corporations to do all the functions like PWD was also briefly discussed. The committee felt that for assigning the work to Public Works Dept. or other bodies, a proper concept

document with general arrangement needs to be prepared first—to enter into an agreement/MoU. Since the University is not having any set up to prepare a proper technical concept document, it was felt that services of a competent consultant may be availed in this regard.

Reported and noted

19. To consider a report on the functioning of the Kalyani, Campus.

All the Schools of Studies have been allotted adequate space in the Kalyani Campus to conduct their diverse academic programmes. Most of the Schools have been provided financial assistance to develop infrastructural facilities to set up smart classes, laboratories, PCP(Personal Contact Program) arrangements with full ICT support in addition to SLMs (Self Learning materials). An audio visual (AV) studio is also to be set up soon to cater to the needs of the students.] Space has been allotted for organising activities of the Central Library of the University at Kalyani campus, under the control of Deputy Librarian. Total area measuring about 2194sqft(approx) on the second floor of the newly constructed three storied warehouse building at Kalyani Campus has been allotted for this purpose.

20. To consider the matter regarding the 14-Non-Teaching employees (Annexure-F)

Reported and deliberated by the House; and it was resolved that the matter be taken up with the Higher Education Dept, Govt of West Bengal, for sympathetic consideration at their end.

21. To report on the on-going litigation [SLP (C) 8497-98 of 2015 & SLP (C) of 13663 of 2015] at the Supreme Court of India regarding validity of NSOU's Ph.D. Degree.

Agenda Note- Order dated 24.12.2014 of arising out of MAT 1068 of 2014 with CAN 9459 of 2014 relating to the case of Dr Abdul Motin –vs- Dr Manisankar Maity. In the proceedings of the aforesaid litigation in the Division Bench of High Court, Calcutta the Ph D degree of NSOU was mentioned as "substandard and not up to the mark". Not only that all the degrees in comparison to its equivalent counter-parts of regular university has been stated as substandard. The matter is now pending before the Hon'ble Supreme Court of India and NSOU is one of the defendants.

22. To report the Court case regarding the post of Co-ordinator, B.Ed. (SEDE)-R.V.W No 84 of 2015 & CAN 3744 of 2015 (A.Panigrahi Vs NSOU & Others).

Agenda Note- As per the last communication from the Advocate of Shri Partha Sen that after hearing the parties High Court, Calcutta has dismissed the above stated Review Application. And at the same time Advocate of Shri Panigrahi intimated the University that very soon they are going to file SLP at Hon'ble Supreme Court and advised the University "to refrain from going ahead with any immediate appointment for the aforesaid post in favour of Sri Patha Sen or anyone else". It is pertinent to mention that the Process of Selection for the Post of Co-ordinator B.Ed (SEDE) was held on 16.07.2010. Selection committee made a single member panel consisting of Shri Partha Sen. But before issuance of appointment letter to Shri Sen, Shri Abhedananda Panigrahi (one of the candidates) challenged the selection of Shri Sen in the court of law on the ground that Shri Sen was having inadequate experience at that material point of time.

Reference for discussion- The process of selection of candidate for the post of Co-ordinator, B.Ed (SEDE) was held on 16.07.2010 and nearly four and a half years have lapsed as it was held up in the courts of law (both High Court and Supreme Court. No appointment letter has been issued till date. The present E.C was constituted in 2012 and the aforesaid selection process has never been reflected in any deliberation(s) of the present EC. Meanwhile as per latest RCI stipulations the B.Ed-ODL(SEDE) course structure and contents have been thoroughly revised.
