Candidates are advised to pay the requisite fee as Demand Draft of Rs. 5,000/- in favour of "Netaji Subhas Open University" payable at Kolkata within **28.03.2024 to 04.04.2024 from 12.00 p.m to 4.00 p.m** on week days by hand in the 2nd floor Ph.D section of Netaji Subhas Open University at DD-26, Sector-1, Salt Lake City, Kolkata-700064 along with a copy of the application form of the candidate and ID proof (such as Aadhaar Card/ Voter Card/ PAN Card/ Passport).

COURSE WORK EXEMPTION:

Candidates from the following category

1. Course Work completion certificate and the course work is compliant with the UGC (minimum standards and procedure of award of Ph.D. degrees) Regulations, 2022.
2. They may get exemption from doing the Course Work and Course Work fee may be waved following University rules/ regulation. The candidate has to apply to the Registrar, Netaji Subhas Open University in the format ("Application proforma for exemption of Course work") available in the Ph.D. admission website. The applicant has to submit the application in prescribed proforma at Netaji Subhas Open University, DD-26, Sector-I, 2nd Floor (Ph.D. Section), Salt Lake City, Kolkata-700064 within 15 days from the date of the publication of this notification by hand along with the demand draft.

Note:

- The fee (Rs. 5000/-) will be refunded, if eligible for exemption from doing course work and approved by the concerned authority of the University.
- Candidates would be admitted depending upon availability of supervisor(s).
